RIGHT TO LIFE NEWS

Brother Knights, the following article was first printed in the November, 2005 issue of *First Things*. I offer it as another example of the extent to which the proponents of abortion-on-demand will go to try and shore up their blood-soaked industry:

• “Study Finds 29-Week Fetuses Probably Feel No Pain and Need No Abortion Anesthesia,” or so the New York Times announced, in a headline based on an article in the Journal of the American Medical Association, which is admittedly based on no new research but offers the opinions of doctors who, it is said, have reviewed the pertinent literature. One of the article’s co-authors runs an abortion clinic and another, David Grimes, is vice president of the pro-abortion organization Family Health International and has personally performed over ten thousand abortions, of which 10 to 20 percent were later than the first trimester. One notes that neonatologists who treat premature babies as young as twenty-three or twenty-four weeks have long observed their patients reacting to painful procedures by crying and jerking away, and they routinely administer anesthesia during surgery. For the New York Times and other pro-abortion publications, denying fetal pain is an important tactic in denying the humanity of these little people. To that end, we are asked to believe that they feel pain in surgery but not when they are being chopped to death. To believe this requires an ideological conditioning of the mind to which most people, fortunately, are strongly resistant

Capital Improvements Required in Early 2006 and the Funding thereof!

“Born 1955 and over the years, our faculties and structures of the Club are requiring replacement rather than repair. Right now we are gathering bids for the replacement of the Council Home roof which is a combination of slate and flat roofing. Estimates for the roof alone are ranging from \$90,000 to \$190,000. We still have the original roof on the catering hall. Upgrades are needed to the Council Home interior such as repair of the ceilings, walls, etc. due to water leakage, replacement carpeting, and upgrading electrical to mention a few. The parking lots need to be resurfaced and some of the HVAC equipment will soon need to be replaced. This all leads to the question “**So how do we pay for these needed and required replacements and repairs?**”

Please remember this issue will be addressed and discussed at the Annual Meeting this month. **IT IS VERY IMPORTANT TO BE AT THIS MEETING AS WE DISCUSS THE STRUCTURAL VIABILITY OF OUR PROPERTY ASSETS!**

Pool Update (Warm things to think about)

As recommend by the Pool Committee and approved by the Board, we have renewed the contract with US Aquatics for the 2006 season. The pool will open Memorial Day weekend, Saturday May 27, 2006. New to this year, the pool will also be open full time starting Monday June 5 from noon to 8PM, two weeks earlier than in the past. You asked for it, we got it. Physical improvements are being planned for the 2006 season over and above last year.

New Sound System in the Council Home

Thanks to our member, **Larry Thum**, a new sound system was installed on December 10, 2005. It sounds great. This is the second time that Larry has donated his time and expertise to help the Club, Inc. Last time it was the new phone system that Larry installed where Larry was able to save us over 33% in cost. **Thanks again Larry!!**

Who founded the Edward Douglass White Council?

Who purchased Reserve Hill?

Reserve Hill? Where's that?

Why does the mansion have a turret?

Who is George N. Saegmuller?

As a person who became a knight this past June I have many questions. While speaking with fellow brothers these are sometimes answered, even with multiple replies. I have been able to get some queries definitively answered. But asking and answering the questions just breed more questions.

We have begun 'The History Project'. This will help answer the above questions and the thousand others that are important, and maybe not so important, but adds color and flavor, to who we are as EDW Knights of Columbus. I have begun reaching out to Arlington County, the Supreme Council archivist and will be approaching descendants of George N. Saegmuller. Now, I'm asking you for help.

You are a vital part of this project; this cannot be done properly without you. If you have any historic information please get in touch with me. In the coming months I suspect we will have items that need to be identified. We will need your help to clarify and identify them.

We envision creating a permanent exhibit within the Council Home, and available on our Web site and in this column.

By the way, Reserve Hill? It's the name of our land; so named because it held an encampment for reserve Union troops in support of the Federal camp at Minor's Hill.

The turret? A water tower. Its design? Came from a beer stein, depicting the Nuremberg city wall, that G.N. Saegmuller gave to the mason to use as a scale model.

Saegmuller? Financed the first courthouse and jail for Alexandria [now Arlington] County. He created the twelve-inch telescope used at the U.S. Naval Observatory; it is still on display at the USNO. He also was the creator of the bore sight for military weapons. He was the holder of 41 patents used by the military and in his optical profession.

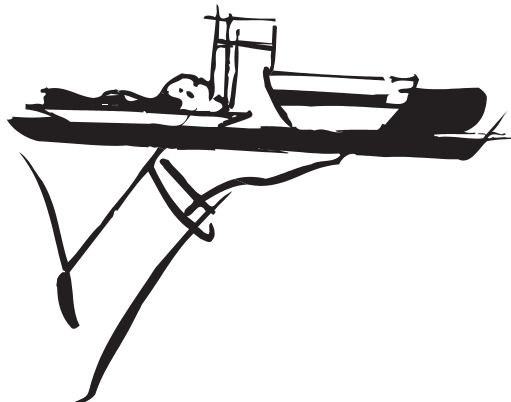
