The St. Thomas More Cathedral School is in need.

This stalwart of Catholic faith-based primary education in the Arlington Diocese is in much need of facility upgrades as well as computer upgrades to continue to educate our future generations.

Although we have been blessed with a large cafeteria, and an adequate school gym, unfortunately both of these areas are so poorly acoustically insulated that they are simply difficult to use. The school gym, which is also used as a multi-purpose room for school functions, PTO and other meetings, must be appropriately insulated so that we can use it to its fullest potential. The cafeteria is so loud during lunchtime and while used for our after school care area, that our students are suffering with what becomes an unbearable roar of their otherwise happy voices. The noise level is unacceptable, and we need help!

With your help, we will continue St. Thomas More Cathedral School's vital role in the community and support the many military families who have chosen our school to educate their children.

Established in 1944, St. Thomas More Cathedral School has grown from sixty kindergarten students to over 300 students in grades pre-K through 8. While tuition goes a long way towards defraying our school's ever growing financial obligations, it does not meet our every need. Some area schools have recently seen tremendous leaps in enrollment and are bursting at the seams. At St. Thomas More, there has been a decline in enrollment the past few years. This decline has only widened the difference between our revenue and financial obligations.

In an attempt at rectifying this disparity, the St. Thomas More Cathedral School PTO will be sponsoring a Spring Auction at your very own Edward Douglass White Hall in May. This will be a special gala evening for our community in an effort to raise the funds that are needed.

You are probably asking, "How can I help?" **Well, please consider donating a service, a dinner or a valuable item that can be sold during our Auction Gala.** Naturally, your generous donation is tax deductible and I can supply you with the School's tax ID number. Or if you are a business owner, please consider advertising your business in our auction program. The rates are very reasonable.

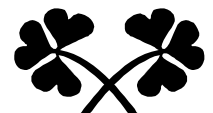
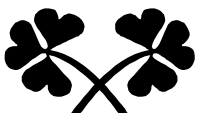

A YEAR IN REVIEW

Last year at this time we took a moment to reflect on the past year and the membership seemed to appreciate it so we are doing it again. 2004 was yet another banner year for Club income with \$1,134,552 in annual income. Almost all budgeted sales projections were exceeded, expenses fell within range of expectations except for some areas not controllable such as depreciation and repairs. (Due to tax law changes we were able to accelerate the depreciation tremendously on our current and newly purchased fixed assets.)

The year started out with the Council Home boilers needing to be replaced in January.

We were able to make some costly repairs needed at the swimming pool along with the purchase of new umbrellas for the pool deck. The snack bar was updated with a new beverage cooler, freezer and fryers. In the Council Home we replaced the kitchen floor and renovated the first floor ladies bathroom with the help of a generous contribution from Ladies U-Knights. The lower level of the main building was renovated through the hard work of member Steve Brown (with help from Mike McMorrow) and paid for by a donation from the Knights of Columbus Waiters. The parking lot was re-stripped in late spring and a new, up to date, phone system was purchased and installed again thanks to the hard work of K of C member Larry Thom.

We have set forth some great goals for the year 2005. Look forward to some great things happening around our facilities, we'll keep you posted!

Actual vs. Budget Fiscal Year 2004



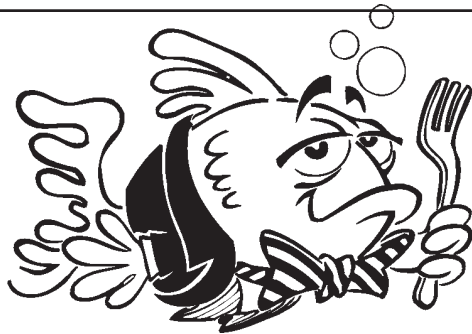
