FINANCIAL SECRETARY'S REPORT

Audit: I am happy to report that we completed the Semi-Annual Audit by the due date of August 15, 2005. I have copies available for anyone who would like one.

Delinquencies: Previously, I have extensively written to inform you of the continuing problem of "aged delinquencies," which unfortunately directly affects the Council's financial resources (as the Supreme and State Councils continue to assess us for their membership- even though they are delinquent!) Per the reports that I ran at the end of May, EDW had 125 members who have been delinquent since prior to January 1, 2004. Of those 125 members, I discovered that 33 were Insured Members and 9 had transferred out of EDW and were being erroneously kept on our books.

In June 2005, I turned over a list of the 33 delinquent Insured Members to our Insurance Agents to help me resolve those delinquencies. I then began a campaign wherein I personally wrote to each of the remaining 83 uninsured delinquent members. In response to the 83 letters that were sent out, 38 Catholic gentlemen did the right thing and submitted their withdrawals or payments- a 45 percent success rate! (God Bless these good men!!!) However, of the 33 names provided to our Insurance Agents, only one responded- which equates to a 3 percent success rate.

I intend to begin action against all delinquent members, as their continued non-payment threatens the financial health of the Council. Quite frankly, though, I am deeply concerned over the success rate posted by our Insurance Agents with maintaining their lifeblood: Insured Members. **As you all know, the removal of an Insured Member for non-payment of dues from the Knights of Columbus would endanger the life insurance policies of the delinquent member and endanger the financial health of their surviving families!!!**

The following is a list of the amounts owed by delinquent members broken out by Insured Members and Regular Members. As part of my column, it will be now be published every month. I intend to add the names of those members who have not paid their dues for the most recent year. If you know someone on this list, please contact them and gently ask them to pay their dues.

RIGHT TO LIFE NEWS

Brother Knights, you may have read in the paper or seen on television the news about the Jason and Susan Torres family of Arlington. On May 7, 2005, the day before Mothers' Day, Susan M. (Rollin) Torres — a 26-year-old vaccine researcher at NIH; wife of Jason; mother of a two-year-old son, Peter; and parishioner at St. Rita's Catholic Church in Alexandria, collapsed. She was rushed to the Virginia Hospital Center in Arlington, where she was diagnosed with stage four melanoma and pronounced brain dead with no hope of recovery. Susan was 17 weeks pregnant at the time with her and Jason's second child and although doctors gave her no hope of survival, her family decided to fight to keep her unborn child alive until the baby could have a viable chance at life. Jason slept by his wife's side at the hospital for the next three months. On Tuesday, August 2, baby Susan, named for her mother, was delivered by Caesarean section. The following morning, after reception of the Last Rites of our Church, mother Susan's body was removed from the machines keeping her alive, and she passed away.

Friends of the Torres family have established The Susan M. Torres Fund to help defray the medical costs that insurance does not cover. Current estimates of the costs range from \$400,000 to \$1,000,000 dollars. The baby's uncovered health care costs are still unknown. Due to the generosity of people worldwide, the fund has raised in excess of \$600,000 as of August 3, 2005. Any excess money will be used to establish a modest College Savings Plan for the baby and her brother and the balance donated to a charity dedicated to the prevention or cure of cancer, in memory of Susan Torres.

Our brother Jason and his and Susan's family showed heroic courage and faith in their struggle so that an innocent human life might be saved. They've done the hard part. Want to help?
