COLUMBUS CLUB OF ARLINGTON BOARD OF DIRECTORS

On February 11, the Board of Directors gathered at a special board meeting called by the president, as permitted in Article IV, Sec. 2 of the bylaws. The purpose of the meeting was to hear fellow EDW Knight Colin Uckert's presentation of how the combination of two unique ideas called a "Transfer of Development Rights" (TDR) and a "Conservation Easement" could secure our future, while keeping our footprint on Little Falls Road. Following the presentation, the President appointed a five-person committee to present these ideas to the membership. The committee consists of Greg Strizek, Owen Beirne, Chris Bannon, Tom Maguire, with Jerry Garren as the committee chairman.

The board met again on February 15, and unanimously agreed to begin an effort to inform the membership of how a TDR, in combination with establishing conservation easements, could generate a substantial sum of money for the club. In doing so, these sorts of transactions have proven to be a safe way for organizations like ours to secure their financial future... again, without selling the property.

The decision to proceed with these innovative ideas will rest upon the membership, not the board. As such, we want to give everyone the opportunity to learn about what they are, how they work, how they could benefit us, and learn the pros and cons. Over the coming few weeks, you can expect to find information about this exciting opportunity on our website, in a special edition of the Knight Life, and in live "town hall" discussions that will be scheduled to coincide with regular Council meetings.

DON'T ASSUME YOU CAN'T AFFORD DISABILITY INCOME INSURANCE

**Profit and Loss Statement of Total Income and Expenses
for the Fiscal Year 2014 vs. 2013 Budget for the
Columbus Cub of Arlington Inc. (CCA)**

Owen J. Beirne Jr.
Dated 2-24-2015

Pursuant the CCA Bylaws, Article III, Section 4, below is the Annual report.

The Total income for 2014 was \$1,943,518, less cost of goods sold of \$296,995, less operating expenses of \$1,491,064, for a total net income of \$155,499. Adding back depreciation, which is a non-cash expense, Total Income was \$269,667 for 2014.

Compared to our 2014 budget, our Total Income was over budget by \$161,067, Total cost of sales was under budget by -\$66,045, and Total expenses over budget by \$102,564, realizing that \$114,168 was depreciation, so really under budget by -\$9,604.

Other notable facts overall:

- Total actual income in 2002 - \$1,119,787
- Total actual income in 2014 - \$1,943,618 Increase of +\$823,831
- Major capital improvements and fixed assets – from 2006 through 2014 = \$1,040,000.00
- From 2003 through 2014 we have made principal payments of \$507,114
- Note to be paid off in May 2016.... Current Loan Balance as of 1-01-2015 - \$93,610
- Cash balances as of 12-31-2014 were \$155,402 with \$14,948 in prepaid Federal and VA State tax deposits

Actual Profit and Loss for 2014 vs. 2013 and the approved 2014 Budget were included in the 2015 Annual meeting packet.
