## RIGHT TO LIFE NEWS

Brother Knights, as Catholic men, we have the honor and the duty to learn and defend our Faith's traditions, dating back to the earthly ministry of Jesus Himself. Please take a look at the following, and know that our Faith's consistent teaching through the millennia is one of recognizing and defending life. (Thanks to Randy Alcorn, Eternal Perspective Ministries, 2229 E. Burnside #23, Gresham, OR 97030, 503-663-6481, www.epm.org )

### The Early Church on Abortion

"You shall love your neighbor more than your own life. You shall not slay a child by abortion. You shall not kill that which has already been generated." (*Epistle of Barnabas* 19.5; second century)

"Do not murder a child by abortion or kill a new-born infant." (*The Didache* 2.2; second century catechism for young Christian converts)

"The fetus in the womb is a living being and therefore the object of God's care" (Athenagoras, *A Plea for the Christians*, 35.6; 177 A.D.)

"It does not matter whether you take away a life that is born, or destroy one that is coming to the birth. In both instances, the destruction is murder." (Tertullian, *Apology*, 9.4; second century)

"Those who give abortifacients for the destruction of a child conceived in the womb are murderers themselves, along with those receiving the poisons." (Basil the Great, *Canons*, 188.2; fourth century)

Jerome called abortion "the murder of an unborn child" (*Letter to Eustochium*, 22.13; fourth century). Augustine used the same phrase, warning against the terrible crime of "the murder of an unborn child" (*On Marriage*, 1.17.15; fourth century).

The early church fathers Origen, Cyprian and Chrysostom likewise condemned abortion as the killing of a child.

"The fetus, though enclosed in the womb of its mother, is already a human being and it is a most monstrous crime to rob it of the life which it has not yet begun to enjoy. If it seems more horrible to kill a man in his own house than in a field, because a man's house is his place of most secure refuge, it ought surely to be deemed more atrocious to destroy a fetus in the womb before it has come to light." John Calvin (sixteenth century reformer)

"I call heaven and earth to witness against you this day, that I have set before you life and death, blessing and curse; therefore choose life, that you and your descendants may live." Deuteronomy 30:19

## COLUMBUS CLUB OF ARLINGTON, INC. TREASURER'S REPORT

### Capital Improvements Required in Early 2006 and the Funding thereof!

Born 1955 and over the years, our faculties and structures of the Club are requiring replacement rather than repair. Right now we are gathering bids for the replacement of the Council Home roof which is a combination of slate and flat roofing. Estimates for the roof alone are ranging from \$90,000 to \$190,000. We still have the original roofs on the catering hall. Upgrades are needed to the Council Home interior such as repair of the ceilings, walls, etc. due to water leakage, replacing carpeting, and upgrading electrical to mention a few. The parking lots need to be resurfaced and some of the HVAC equipment will soon need to be replaced. This all leads to the question "So how do we pay for these needed and required replacement and repairs?" Several sources come to mind 1) raise the dues, 2) increase the beverage prices, 3) do a special assessment of all the members for a building fund, 4) establish a Building Committee to raise the funds through donations, 5) finance the improvements with a local bank via a loan. All of these sources are being considered, however the most practical and logical solutions are the borrowing of the funds from a local bank or have the members approve a special assessment of all the members so that all the replacements can be done at once. As I mentioned, most of these items are critical to the longevity of the faculties and the grounds. This issue will be addressed very early in 2006 and will

require swift approval from us, the members. No longer can the inevitable be put off.

### Cell Tower Update

On November 1, 2005 at 12:06AM, the Nextel switched was flipped for the cell tower and life was good. They are still finishing the construction on the exterior of the building but the rent commenced July 2005, so the money is good. We are currently in negotiations with Cingular Wireless. The Cingular negotiations should be concluded very shortly. This would bring the total number of cell towers on campus to three of the major providers. **Special thanks to Mike Kearny** who has overseen the entire construction process from start to finish. Mike did a fine job in protecting the Club and the exterior of our grounds.

### Legal Representation of the Columbus Club of Arlington, Inc

I would like to thank **Colin Uckert** who is a member of our council and a partner of the law firm POWELL, GOLDSTEIN LLP of Atlanta and Washington DC, for having his firm now represent our Corporation pro bono. This level of advice and representation has helped us tremendously with cell tower lease negotiations as well as other legal issues. We are truly blessed by the caliber of talent of those members who donate their expertise to our Club and Council. Thanks Colin!
