SMOKING IN THE COUNCIL HOME

During 2006, many many members have come to me about the issue concerning smoking in the Council Home. Their question is always the same "If we have not allowed smoking in the Main Hall for many years, then we do we continue to allow it in the Council Home?"

Recently there was an editorial in the Washington Post on December 11, 2006 titled "Stub It Out." Here is some of the information that it pointed out:

"... A landmark report by the surgeon general in the summer confirmed that breathing in smoky bars, restaurants or waiting rooms causes lung cancer and heart disease, not to mention chronic coughs, irritated nostrils and, for pregnant women who wait on tables or tend bars in smoke-filled establishments, babies with lower birth weights. The report also poured cold water on complaints from restaurant and bar owners: There is growing evidence that more people will frequent restaurants and bars when a smoking ban is in place."

".....More forthright leadership is needed. Restaurants are prohibited from serving poisonous food, so why should they be able to subject customers to toxic air? Moreover, smoking no longer has the constituency it once did as the number of smokers nationally, and in Maryland and Virginia, has fallen in recent years, thanks to the higher cost of cigarettes and aggressive publicity campaigns. And the hospitality industry's arguments about the economic peril posed by smoking bans have crumpled like a used pack of Winstons.

"Perhaps a careful reading of the surgeon general's report will help convince Maryland and Virginia governors and other officeholders that the time is right to get serious about secondhand smoke. Then-Surgeon General Richard H. Carmona said in June: "Smoke-free environments are the *only* approach that effectively protects nonsmokers from the dangers of secondhand smoke."

So what do we do? Pursuant our Corporation's By-Laws, "The purpose for which the Corporation is established includes, among other objectives, the promotion of charitable, spiritual, educational, recreational, and community interests and to maintain and operate the real and personal properties located at 5115 Little Falls Road..." As the board of Directors we must address this issue once and for all.

The membership also needs to address this issue in an open forum, then a debate in sue, options be looked at, and then a vote be taken that reflects our councils true feeling on this matter. We can not let this question, I feel, linger any longer and we as a Board of Directors must fulfill our duties and responsibilities.

My job is to bring the issue to you, our members, not with a stand but with the concerns and facts. Perhaps the Annual Meeting on January 4th, 2006 is the time to start!

FROM THE DESK OF THE FINANCIAL SECRETARY

Back to Back Dues Mailing: I have received a number of inquiries concerning the two dues notices that were mailed during the first few days of December. Please be aware that I deliberately delayed the mailing of the 2006 Fourth Quarter notices until a few days before mailing the 2007 notices. Again, this was purposely done in order to "get the attention" of those members who had not yet paid for 2006. Resultant of this back-to-back mailing, a significant number of members have been brought up to date. Unfortunately, due to the timing associated with this effort, the 2007 notices also included the amount of 2006 arrears amount. If you were one of the "Good Knights" who paid their 2006 dues as a result of the first mailing, please make sure that you deduct the amount of your 2006 payment from your 2007 payment.

Dues Payments: The 2007 dues amount for Regular Members is \$112.00, comprised of \$70 in Council dues and \$42 in Columbus Club dues. When paying your dues, inclusion of your dues notice is helpful, but not necessary. As such, Brother Knights can simply mail a check in the amount of your dues to the Council and I will ensure that it is processed. Paying your dues in full minimizes administrative costs and helps the Council, overall. When paying your dues, please remember to add a few dollars to the "Penny a Knight a Day (PKD) Fund, the Building Fund, and the Charity Fund.

Annual Meeting: Please remember that you must be a "member in good standing" (defined as a Knight who pays his dues) to be admitted to the Annual Columbus Club Meeting. Payments will be accepted at the door.

Honorary Life Members: As you well know, the Supreme Constitution provides that Honorary Life Members (HLM) receive a full exemption from the payment of Council dues. However, there is a clear misunderstanding of the rules concerning Columbus Club dues. Please be aware that the By-Laws of the Columbus Club DO NOT provide for the exemption, or reduction, of dues for these special members. As such, HLMs are reminded that they are OBLIGATED as Catholic Gentlemen to pay Columbus Club dues (\$42) in order to ensure that sufficient funds are available for the operation of the grounds. Such dues payments are particularly important considering that the Columbus Club Board of Directors has embarked on a campaign to raise funds to improve the EDW grounds and ensure our future existence. The Council Officers, Columbus Club Board Members, and I are very interested in accommodating HLMs who may be experiencing financial problems. If you are an HLM (a treasured member) who needs an accommodation, please contact me immediately to discuss potential options. However, in keeping with the previous ruling of the State Advocate, HLMs who fail to pay or contact me will remain members in good standing and permitted to attend Council meetings. However, they will NOT be permitted to utilize Columbus Club facilities.

A Special Note to EDW's Retirees: I want to thank you for providing me with the opportunity to speak to you at your weekly meeting in late November. I truly enjoyed speaking to you as a group, as well as talking with many of you individually. The overall experience left me with the realization that we are truly Brothers and feeling a bit closer to all of you. Do not hesitate to call me. I am here to help in anyway possible.

Thank You: To Bob Muschamp...I really appreciate all the help you have given me with the organization of both of the dues mailings over the last month.

CAPITAL CAMPAIGN KICKOFF IS HUGE SUCCESS

The EDW Capital Campaign got off to a fabulous start last month. Since the end of the summer, we have raised over \$74,000 (\$53,000 in cash and \$21,000 in pledges). So far, 42 individuals have each contributed \$1,000 or more in cash and 49 others have contributed between \$100 and \$500.

This is a great start, but, as you know, we are still a long way from our goal to raise \$1 million over the next four years. In order to accomplish this, we need to have everyone participate in any way they can.

We realize that some members are on fixed incomes or have staggering education expenses and are not able to make a large contribution. We are asking each member to decide what they can afford and over what time frame they can make a contribution. A number of members have decided to send a small check monthly; others have opted to make a quarterly contribution; still others have decided to make an annual contribution on top of their payment of membership dues. Whatever works for your individual situation will be welcomed by all of us.

Some members have asked if they can make their contributions in memorial to a deceased loved one. To accommodate these requests, we have set up a special memorial plaque (pictures optional) to be displayed prominently in the Council Home with appropriate acknowledgements.

Also, in this Holiday Season, it would be a great gift to make a contribution on behalf of someone so that they would be recognized as a sponsor or patron of the Knights of Columbus.

Thank you for your generosity and please help us reach our goals for putting EDW on a sound financial footing for the future.
