## WE NEED A FEW GOOD MEN!

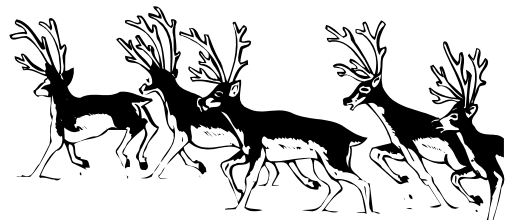

## FROM THE DESK OF THE FINANCIAL SECRETARY

### "The 2008 Dues Rant Issue"

You should receive (or have received) your dues notice for 2008 in early December. If you have not, please be aware that you can mail a check to the Council without your billing slip. In the event that you do, please remember to write your membership number in the memo section of the check. Dues will increase by \$2.00 in accordance with the resolution previously passed by the Columbus Club in 2003. Regular Members' dues will be \$114; Honorary Members' dues will be \$60, Honorary Life Members dues' will be \$44 (Columbus Club dues only).

Please remember that a "member in good standing" is defined simply as a Brother Knight who pays his dues. But the FAILURE of a member to pay dues actually HURTS the Council finances, as there are significant costs associated with each membership (e.g., State and Supreme dues that MUST be paid, even if a member does not pay). So, if you fail to pay, you cause DAMAGE to the finances of this CHARITABLE organization.

This having been said, the Council will help any Brother Knight who cannot pay their dues. All you have to do is to write to fs2473@hotmail.com or call me at (202) 498-1638 and I will help. Also, if you are in arrears, please take the time to call me to discuss your particular situation. I am here to help.

Please be thoughtful...pay on time...and if you are no longer interested in membership at EDW, please contact me to arrange withdrawal or, if still interested in membership, transfer to another Council.

As you well know, the Supreme Constitution provides that Honorary Life Members (HLM) receive a full exemption from the payment of Council dues. However, there is a clear misunderstanding of the rules concerning Columbus Club dues. Please be aware that the By-Laws of the Columbus Club DO NOT provide for the exemption, or reduction, of dues for HLMs. As such, HLMs are reminded that they are OBLIGATED as Catholic Gentlemen to pay Columbus Club dues (\$44) in order to ensure that sufficient funds are available for the operation of the grounds. The Council Officers, Columbus Club Board Members, and I are very interested in accommodating HLMs who may be experiencing financial problems. If you are an HLM (a treasured member) who needs an accommodation, please contact me immediately to discuss potential options. However, in keeping with the previous ruling of the State Advocate, HLMs who fail to pay or contact me will remain members in good standing and permitted to attend Council meetings. However, they will NOT be permitted to utilize Columbus Club facilities.

All Federal employees are reminded that it is VERY easy to support the Virginia KOVAR charity through regular payroll deductions made possible through the Combined Federal Campaign (CFC). ## EDW'S OPERATION CHARITABLE RESOLVE

### Collecting and Aiding Baghdad's Catholic Community

In last month's Knight Life we introduced you to EDW member LTC Bill Davisson, currently stationed in Iraq, who had written the membership to share the story of Father Nahdeer, one of the few remaining Catholic Priests. As part of the Knights of Columbus Baghdad Roundtable, Bill had asked if we could assist Baghdad's struggling Catholic community with our prayers and charity. These are dozens of displaced families and children living in a hostile environment, who need – and would greatly appreciate – some very basic items.

Now is time for us to act. Starting immediately, EDW will begin collecting goods to be sent to Brother Bill and the Baghdad Roundtable for direct distribution to our fellow Catholics in Iraq. Collection drop-boxes will be located at both the Council Home and Main Hall. We'll concentrate on the following items:

- Hygiene articles (linens, and non-prescription medicine)
- Kitchen gear (pots, pans, and utensils)
- Children's gifts (simple toys not requiring batteries)
- Non-chocolate candies
- School supplies (composition books, pencils, pens, etc...)

The Council will keep you posted on Operation Charitable Resolve in both the Knight Life and on the Website with updates on what we send and any correspondence with our man in the Baghdad .

Understanding that there are many other calls for your generosity this time of year, please keep in mind this worthy cause. Imagine the bravery required to be a practicing Catholic in that war-torn region. Remember our soldiers and civilians stationed in Iraq and Afghanistan who continue to win the hearts and minds in difficult and dangerous circumstances. # PROPOSED 2008 BUDGET FOR COLUMBUS CLUB OF ARLINGTON, INC.

Enclosed in this December Knight Life is the Corporation's Proposed 2008 Budget for your review pursuant to the By-Laws, Article V, Section 7. This budget will be presented at the Annual Meeting of the Corporation, which will be held on Thursday, January 3, 2008, for membership approval.

We have examined the actual revenue and expenses for 2007 year to date (through 9-30-2007) and reviewed all of our maintenance contracts. We feel confident about the 2008 budget.

In summary, 2007 was quite a year of change for us as a corporation.

For the first time ever, we hired a Chef for the Club, Ernest Todd, who started in January of this year. Also, in the fall of 2006, we created and filled, for the first time, a new position for an Event Director, Stephanie Kingree, which carried over into 2007. This new position allowed us to have a central point of contact for all prospects and clients for all of the campus events. The benefits have been better coordination of events, planning and client satisfaction. However, we were still without a Club Manager until April of this year when Jesse Corning joined us. The results are just being shown in 2007 of this newly created team. With 2007 vs. 2006 through 9-30-2007, food sales are up 14%, facilities rental up 41%, and labor charged is up 44%.

We also finished the all the items in our 2006 Capital Improvement Plan and we now have flat screen LCD's in the Council Home.

Here are some other numbers to look at: Pool income was up 17% (highest income ever in Club history) and net income was up 22%. Camp income was up 17% and net income was up 55%. The snack bar/pool lounge revenue was at an all time high ever at \$91,000 with \$4,700 coming in the weekend after Labor Day due to the End of the Year Pool Party.

We have two loans outstanding – 1st loan dated 12-10-2004, we borrowed \$100,800, 5 year note at 7%, current balance – 12-2008 - \$44,634. 2nd loan dated 1-28-2006, we borrowed \$211,482, 5 year note at 7.75%, current balance - 12-2008 - \$176,551.

The cell agreement with AT&T will be executed this month with construction completed in the fall of 2008. This rent is not included in the 2008 budget.

In 2007 we made changes to our business practices to better serve the membership of the Council and our external customers.

We are using the full potential of our Chef's abilities and are now only doing catered events in the Main Hall.

We completely revamped our menus and pricing for the Main Hall and for summer picnics. Everything is now on a cost plus basis.

We have a well defined inventory

process in place.

We have revised our event and meeting contract so that we have a more professional approach when we are meeting our client's needs.

We have put in place a marketing plan that is now far reaching to all. We have joined the Arlington Chamber, the Ballston Partnership and we are hosting Chamber Mixers in our main hall, we are attending bridal showcases and events.

We have now made our kitchen truly a "commercial kitchen" with needed equipment purchases (do not ask what we used to mix things in the kitchen with).

We have bought stand up cocktail tables, cloth chair covers, and other equipment that we now rent out to for all events. The new motto is "bring on the events" we are ready and now equipped to handle one and all.

As far as our financial outlook, our budget is very conservative for 2008 and we feel fiscally sound. Our 2006 approved improvement budget was completed this year; however we are creating a 2008 improvement budget. This will include the entire white coating of the pools, possible resurfacing of the pool decks, and a new barbeque pit structure (current one is in great disrepair). Resurfacing of the tennis court and possibly re-roofing the main hall roofs. Should we mention the resurfacing of the lower parking lots and other areas? This is why the Capital Campaign Fund is so important.

We are very optimistic about our future booking of the hall, the increasing success of our Summer Camp, and the continued success of our pool as we strive to make our pool better each and every year. We feel confident we have a solid staff in place in and great leadership in key roles.

However, the 85 years of success (May 1922) of our Council and Corporation comes from only one source, and it's not the money, it's from you, the member who volunteers and supports this great institution. If you can help in any way, call me or e-mail me at owen\_beirnejr@ml.com. The pay is great!
