Both the Family Buffet and the Friday Night Supper Club are casual dining opportunities provided for EDW members and their families/friends at reasonable prices and (what we hope are) convenient hours.

The Family Buffet is generally held on the first Sunday of most months (exceptions being May-Mother's Day, 2nd Sunday; and July & Sept. - Holidays). Hours are (currently) 2:30pm-5:30; hours may change subject to member/customer survey. Usually at least three entrees (meat, poultry, fish, pasta); several "sides" two soups, plentiful salad bar, dessert, coffee, tea. Cash bar for beer, wine & soda. This is relaxed dining in a casual atmosphere; NO RUSH.

Supper Club is another longstanding EDW tradition. Currently Supper Club is offered two Fridays a month (may vary depending on other events scheduled). Served Buffet style (per Family Buffet), also with similar wide selection of entrees, starches, veggies, soups, salad bar, desserts, etc. "Regulars" at Supper Club take advantage of the "Price-Buster" card (like a "frequent-diner" card) which entitles one to a free meal after 5 paid meals!

All are welcome to attend, and bring friends and relatives. You're missing out on a good deal if you don't try out both the Family Buffet and the Supper Club. Note: reservations are requested by Friday noon for Supper Club. See further details and menus in Knight-Life.

SMOKING AT THE POOL LOUNGE

Philip Morris USA states "Public health officials have concluded that secondhand smoke from cigarettes causes disease, including lung cancer and heart disease, in non-smoking adults, as well as causes conditions in children such as asthma, respiratory infections, cough, wheeze, otitis media (middle ear infection) and Sudden Infant Death Syndrome.

"...We [Philip Morris] believe that the conclusions of public health officials concerning environmental tobacco [secondhand] smoke are sufficient to warrant measures that regulate cigarette smoking in public places."

"...Particular care should be exercised where children are concerned and adults should avoid smoking cigarettes around them."

The U.S. Surgeon General stated "The good news is that ... secondhand smoke exposure is easily prevented, ... Smoke-free indoor environments are proven, simple approaches that prevent exposure and harm. The report finds that even the most sophisticated ventilation systems cannot completely eliminate secondhand smoke exposure and that only smoke-free environments afford full protection."

April 22, 2008 — The Columbus Club Board of Directors voted 5 to 4 to continue to allow smoking at the pool lounge this summer. Two of the stated reasons for their decision is that the board has not received any letters complaining about smoking at the Pool Lounge from Knights of Columbus members and some did not believe the evidence of the dangers of secondhand smoke.

SO HOW MUCH DOES THE CLUB CORPORATION PAY IN REAL ESTATE TAXES (RET)?

Very often I am asked this question from members and non-members as they look out or walk around our 10 acre estate. Since the Corporation has a 501(7) tax status, we are not a non profit organization; however we are categorized as a "Social Club"

Here are some facts:

- In 2001, we paid RET of \$28,000 on an assessment of \$3,003,000, rate was \$0.924 per \$100
- In 2002, we paid RET of \$52,687 on an assessment of \$5,286,700
- 2004 - \$ 54,899
- 2005 - \$ 50,413
- 2007 - \$ 62,544

Our assessment has gone up steadily over the years. Our assessment for 2008 is now \$8,906,300. Our Real Estate Tax bill for 2008 is \$75,525 based on an assessment of \$8,906,300 at a rate of \$0.848 per \$100. We budgeted \$68,000, so we now have an increase of \$7,252 over our 2008 budget number, or a 20.3% over our actual 2007 RET bill – increase of \$12,708.

I mention this because, as members, we only pay dues of \$114 per year. Of the membership dues collected and according to a formula in the By-Laws, the Corporation receives about \$40,000 for the operation of the over all estate. Doing the math, the \$40k pays about 53.15% of the RET. The remainder of the revenue to pay the real estate taxes and all other variable and fixed expenses has to come from the success of the pool, pool concession stand, summer camp, Main Hall, and the Council Home. A pretty tall order!

So when you read Jim Savarese's article about the Capital Campaign Fund (CCF), I hope this answer illustrates what we, as a Club, face as a corporation. We need to reach those goals that Jim has so eloquently spelled out in his article as we move forward to complete our capital improvements. I know we have a great corporation in place, that we have great members on the KOC Council and the Board of Directors, and a great staff that works towards all of our goals.

So when you look at the membership dues of \$114, think about how else you can help this Council and Club - from a professional level, from being a red coat, from being on the Council or Board, to contributing to the CCF or coming to events. \$114 per year is equal to about \$0.32 per day.

EDW CAPITAL CAMPAIGN: THE SECOND YEAR

The EDW Capital Campaign will complete its second year on Labor Day. This is an extremely important time to make a big push in our commitment to the physical health of the Council's infrastructure.

This summer we plan to undertake a number of renovations that will cost over \$150,000. At the Memorial Day picnic you will see a new cookout pavilion which cost \$20,000. We are taking bids on repairing the tennis courts and parking lots. We have begun work on a major overhauling of the lower lounge in the main building to make it useful for functions that might not be large enough for the main hall.

We are also establishing a Contributors' Wall in the foyer of the Old Council Home. This will contain plaques with names of contributors to the Capital Campaign since its inception. We will recognize contributors in four groups:

- \$1000 EDW Silver Club
- \$2500 EDW Gold Club
- \$5000 EDW Platinum Club
- \$10000 EDW Lifetime Benefactor Club

In order to be a member of any of these clubs, all the contributions an individual has made to the Capital Campaign are added up. As additional contributions are made through time, our Brother Knights move up, as appropriate, to the next highest club.

We are going to use these next three months to attempt to get maximum participation in this effort. If you already made a significant contribution during the Campaign's first year, try to see if you could match it in the second year. If you have made a modest contribution the first year, please take a hard look and see what you can do now. If you are one of the eighty percent who has not made a contribution, please see if you can do something to help out your Council.

In addition to recognizing contributors, plaques will also be available in Memoriam to loved ones who have passed away. This can be accomplished by a contribution on behalf of the deceased by a family member, friend, or any number of individuals who choose to honor the deceased. The goal, of course, would be to reach one of the thresholds as described by the plaques.

It is important to note that the plaques will be based on the actual, cumulative contributions made to the Capital Campaign. As pledges to the Campaign are fulfilled, they will be included in the totals.

We really need to raise \$300,000 over the next two years to make good our commitment to the Council and pay for the needed capital improvements which are ongoing. Please do your part as your Council really needs your support.

JUNE UPDATE ON THE CAPITAL CAMPAIGN AND CAPITAL IMPROVEMENTS 2008

Capital Campaign Fund (CCF) and Capital Improvements

– As promised, each month we are going to tell you the “how much is in the fund, how much did we spend so far year to date, and what have we contracted for YTD.” Since my May update, the BOD has approved \$60,895 for capital improvements so far for 2008. As of 5-12-2008 the CCF fund was at \$95,760 with \$26,663 of the \$60,895 already being disbursed for capital improvements. Below is a CCF summary:

- As of 5-12-2008, CCF balance \$96,760
- Improvements to be paid \$34,262
- Net Funds Available to Use From CCF \$62,498

Since my last update, the BOD has approved a contract for \$24,172 with Miles Glass to completely replace the sliding glass doors/wall in the MH and install a storefront with two sets of double doors (1” tempered insulated units). We also approved \$1,828 for any repairs needed to the top or bottom of the storefront installation. It will look exactly like the storefront installed at the loading dock. This work will be completed by the end of June 2008. This new storefront will also greatly improve our HVAC costs. It’s been a long time coming and it will make a vast improvement for marketing the MH. As you can also see, the nice, new, bright floor has been installed in the Lower Lounge. The BOD is also looking into the feasibility of other improvements for the Lower Lounge such as a new ceiling grid and doubling the light fixtures, drywall the foyer, redoing the walls and the bar, and other items

for a complete renovation. We are also continuing on other items as you can see in the excel spread sheets included in this Knight Life. And lastly, just look at that new GREEN BBQ roof, new exhaust fan, and new lighting.

Refinance of our two Promissory Notes– The BOD’s was able and approved to refinance of the two current loans into one Promissory Note for \$200,000 at a fixed rate of 6.5% for 5 years. (This was done on May 8, 2008). There are two things that you want to accomplish in any refinance; (1) lower your monthly payment and (2) lower the interest rate. We have accomplished both in this case and in fact we will have a savings of about \$180 to \$200 in monthly interest expense and our monthly P&I payment went from \$6,462 to \$3,913, improving our monthly cash flow. The total cost to refinance was \$250. All the terms have stayed the same and most importantly, we can pay repay the note at any time without penalty. This loan was done with Chain Bridge Bank located in McLean with the help of one of our members, John Brough, who is also the President and CEO of the bank. Thanks John.

I also want to thank another member, Jim Nelson of Potomac Bank of Virginia, who has helped us with our financing since 1999. Do to Jim’s efforts in providing the financing, major improvements have been accomplished such as the Main Hall and Council Home renovation and everything else that you can see. Here we had two brother members, from competing banks, who worked for the common good of the KOC. Thanks gentlemen!
